1. In this "Terms of Use," unless otherwise indicated by the context, the following terms shall have the following meanings:

"CITIC CLSA" refers to CLSA Limited – a licensed corporation authorized to engage in regulated activities under the Securities and Futures Ordinance (Hong Kong Ordinance Cap. 571) including Type 1 (Dealing in Securities), Type 4 (Advising on Securities), and Type 7 (Automated Trading Services). (Central Entity Number: AAB893) and a participant on the Hong Kong Stock Exchange;

「本公司 / 我们 / 我司」是指中信里昂；

"our company / we / us/our" refers to CITIC CLSA;

「阁下 / 您」是指是公司或其他法律实体的客户或是自然人的客户；

"you / your" refers to clients of companies or other legal entities, or individual clients;

「许可目的」是指按照中信里昂的规定透过使用 CATS 系统进行证券买卖；

"Authorized Purpose" refers to executing securities trading through the use of CATS System in accordance with CITIC CLSA's terms and conditions;

「CATS 系统」是指 CATS 自动交易平台；

"CATS System" refers to the CATS Automated Trading Platform;

「这项服务」是指为中信里昂的认可客户提供的程式买卖服务，允许他们使用 CATS 程式进行证券交易服务；及

"This Service" refers to the program trading service provided to approved clients of CITIC CLSA, allowing them to use the CATS System for securities trading activities; and

「《业务条款》」是指中信里昂不时订定的《业务条款》(CLSA Asia-Pacific Terms of Business) (请参阅网站 <https://www.clsa.com/terms-of-business/>) 及其附录、修订、补充文件。

"Terms of Business" refers to the "CLSA Asia-Pacific Terms of Business" of CITIC CLSA, as amended and supplemented from time to time (please refer to website <https://www.clsa.com/terms-of-business/>) and their annexes, amendments, and supplementary documents.

Any other terms set forth in bold font in this "Terms of Use," which are not separately defined herein, shall have the same meanings as specified in the "Terms of Business."

2. 阁下透过 CATS 系统进行任何证券买卖之前应该：

2. Before you execute any securities trades through the CATS System, you shall:

(a) 熟悉 CATS 系统的资讯和功能，并在必要时寻求独立的专业意见；

(a) Be familiar with the information and functions of the CATS System, and seek independent professional advice if necessary;

(b) 充分理解和考虑每一项交易所涉及的固有风险；

(b) Fully understand and consider the inherent risks involved in each transaction;

(c) 熟悉 CATS 系统的功能、运作和限制；

(c) Be familiar with the functions, operation, and limitations of the CATS System;

(d) 仔细阅读、了解附录 1《风险披露声明》的内容并充分评估透过 CATS 系统进行证券买卖涉及的风险；

(d) Carefully read, understand, and review the contents of Appendix 1 "Risk Disclosure Statement," and fully assess the risks involved in conducting securities trading via the CATS System;

(e) 确定每一项交易符合阁下投资经验、投资目标、财务状况、投资年期、风险承受水平、流动性需求、（如适用）阁下对相关股票发行人的潜在表现及信誉的看法、税务情况、分散投资的需求和其它相关情况；

(e) Confirm that each transaction aligns with your investment experience, investment objectives, financial situation, investment horizon, risk tolerance, liquidity needs (if applicable), your views on the potential performance and creditworthiness of the relevant stock issuer, tax considerations, diversification needs, and other relevant factors;

(f) 仔细阅读 CATS 系统的《操作手册》、《业务条款》（包括但不限于有关电子交易、风险披露的规定）、中信里昂的《个人资料保护法律附录》(CLSA Asia-Pacific Annex - Personal Data Protection Laws)(请参阅网站 <https://www.clsa.com/terms-of-business/>)、《私隐政策声明》(Privacy Policy Statement) (请参阅网站 <https://www.clsa.com/privacy-policy-statement/>) (《个人资料保护法律附录》和《私隐政策声明》统称为《通函》) 及本《使用条款》，并同意受其约束；及

(f) Carefully read the "User Manual" of the CATS System, the "Terms of Business" (including but not limited to provisions related to electronic trading and risk disclosure), CITIC CLSA's "Personal Data Protection Laws Annex" (CLSA Asia-Pacific Annex - Personal Data Protection Laws) (please refer to website <https://www.clsa.com/terms-of-business/>), the "Privacy Policy Statement" (please refer to website <https://www.clsa.com/privacy-policy-statement/>) (the Personal Data Protection Laws Annex and the Privacy Policy Statement collectively referred to as the "Circular,") and this "Terms of Use," and agree to be bound by them; and

(g) 确保阁下的证券户口内有足够的资金以进行交易。

(g) Ensure that you have sufficient funds in your securities account to carry out the transactions.

3. 如果阁下不了解 CATS 系统的运作、涉及的风险，或不能承受相关风险带来的损失，我们建议阁下不要使用 CATS 系统进行证券买卖。如果阁下下载/使用 CATS 系统，我们将认为您已经完全了解并愿意承受相关的风险以及由此带来的损失。此外，透过进入 CATS 系统进行任何证券买卖时，阁下确认已详细阅读并接受 CATS 系统的《操作手册》、《业务条款》、

本《使用条款》、《通函》和《风险披露声明》（见附录 1）并同意受其所约束。如果阁下不明白、不接受或不同意任何条款的话，请不要使用 CATS 系统进行任何交易。

3. If you do not understand how the CATS System operates or the risks involved, or if you are unable to bear the losses arising from those risks, we advise you not to use the CATS System for securities trading. If you download/use the CATS System, we will consider that you have fully understood and are willing to bear the relevant risks and the losses resulting from them. Additionally, when executing any securities trades through accessing the CATS System, you confirm that you have read in detail and accept the "User Manual," "Terms of Business," this "Terms of Use," the "Circular," and the "Risk Disclosure Statement" (see Appendix 1), and agree to be bound by them. If you do not understand, do not accept, or do not agree with any terms, please do not use CATS System to make any transactions.

4. 阁下了解，如果您通过 CATS 系统进行任何证券买卖，我们会收取常规佣金、征费和费用。

4. You understand that if you carry out any securities trading through the CATS System, we will charge the usual commissions, levies and fees.

5. 这项服务通过审批后仅供阁下或阁下在本公司已登记的授权代表使用。凡是使用阁下的用户名和密码就授权证券账号进行的委托以及透过 CATS 系统发送的交易指令均会被视为阁下亲自办理之委托和交易，由此所产生的一切后果由阁下承担。阁下了解并确认中信里昂仅授予您或阁下在中信里昂已登记的授权代表的一项非排他性、不可转让和只供您使用的有限许可，仅可为许可目的，在您拥有或控制的设备上安装和使用 CATS 程式。

任何算法仅作为交易辅助工具，投资者使用算法交易存在如下风险：

Any algorithm is only a trading aid, and investors using algorithmic trading are subject to the following risks:

1. 阁下须留意CATS 系统内可提供的股票算法的品种及使用时间。若有所更改，请留意CATS 系统上的更新，我司将不再另外通知。

1. You should pay attention to the types of stock algorithms available within the CATS System and their usage times. If there are any changes, please note the updates on the CATS System; our company will no longer provide separate notifications.

2. 所占量比风险：对证券交易价格和交易量造成显著影响的交易行为很可能被交易所认定为异常交易行为，并因此被交易所采取警示、暂停或限制交易等措施，我司有权采取任何相应行动。建议阁下加强交易量比的风险控制，避免交易量占同时段市场交易量比重过高，我们建议该交易量比最好不超过 20%。

2. Market share risk: Trading activities that significantly impact security prices and trading volumes are likely to be deemed abnormal trading behaviors by the exchange, which may result in warnings, trading suspensions, or restrictions by the exchange. Our company reserves the right to take any corresponding actions.
